The meeting will be held at **The Barn at Timber** Cove. Tickets go on sale April 1. The cost per ticket is \$5.00.



Are my deposits in KTCCU Government?



Credit Union Association (NCUA).

- Accounts owned by one person (Single Ownership) are insured up to \$250,000.
- Accounts owned by two or more persons (Joint Ownership) are insured up to \$250,000.
- > IRAs and other retirement accounts are insured up to \$250,000.
- Trust accounts, each owner is insured up to \$250,000 if the owners are members of KTCCU.

If you have each of the above KTCCU accounts, your deposits are insured up to \$250,000 per account.

Go to mycreditunion.gov/insurance-estimator to determine your level of insurance coverage.
