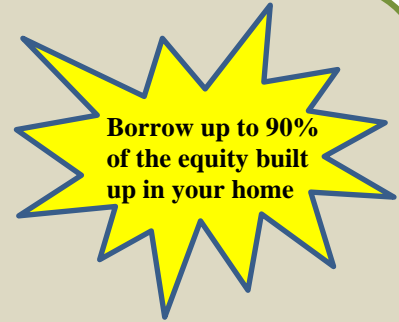


HOME EQUITY LOANS

KTCCU’s annual meeting will be held **on Friday, April 23, 2021.**

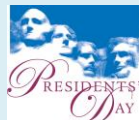
The meeting will be held at **The Barn at Timber Cove.** Tickets go on sale April 1. The cost per ticket is \$5.00.

Ask the President

Are my deposits in KTCCU protected by the Federal Government?



Yes, your deposits are insured by the National Credit Union Association (NCUA).

- Accounts owned by one person (Single Ownership) are insured up to \$250,000.
- Accounts owned by two or more persons (Joint Ownership) are insured up to \$250,000.
- IRAs and other retirement accounts are insured up to \$250,000.
- Trust accounts, each owner is insured up to \$250,000 if the owners are members of KTCCU.

If you have each of the above KTCCU accounts, your deposits are insured up to \$250,000 per account.
